That you note the below updated details around the discovery on elevated lead levels at Yarralumla Primary School.

## Noted / Please discuss

## Yvette Berry MLA..../..../....

- Infrastructure and Capital Works through ACT Property Group have been undertaking replacement of windows at Yarralumla PS due to the deteriorating condition of the lead paint.
- The work includes the complete removal and replacement of window units to limit the disturbance of the lead paint coating.
- Testing of the nearby surfaces was undertaken on Wednesday 15 July as standard process. The results of this test were received by ACT Property Group on 17 July and showed elevated lead levels in 8 rooms
- ACT Property Group arranged for an environmental clean of the classrooms over the weekend of 18 and 19 July and retesting was undertaken.
- Test results were received on 21 July and elevated levels were still detected. ACT Property Group advised the school they could not use the rooms until further work had been completed.
- ACT Property Group are discussing the work practices used with the contractor to determine if the source of lead relates to the removal of the windows or if it was pre-existing.
- The school has made arrangements to temporarily relocate all affected classrooms for the remainder of the week.
- Further cleaning and testing has occurred throughout the week with negligible improvement in the results.
- On Friday 24 July, Education representatives met with the ACT Property Group and the Environmental Hygienist and developed a new cleaning methodology. The new procedure for cleaning will be employed in the classrooms over the weekend with results being expected by Wednesday or Thursday.
- As part of the revised cleaning procedure all non-essential material will be removed from the space.

• As an added precaution, the Environmental Hygienist will visit the school after school hours on Friday 24 July and undertake surface sampling in areas across the site to establish the magnitude of background contamination. These results are expected Tuesday or Wednesday.

As discussed, Deputy Principal Deb from Yarralumla PS has advised that her business manager was told by a member of the ACT property group that 8 classrooms have failed Robinsons initial testing for asbestos and lead, with trace amounts of lead found in the carpet.

ICW has been conducting works to remove lead based paint found on windows in classrooms within Yarralumla PS. The Business Manager has been advised that no trace amounts were found in the air however trace amounts were identified in the carpet. The carpet has been covered with a double layer of plastic for the duration of the works. The Business Manager was further been advised that there was extremely low risk to students, however as the cover is being removed tonight, students and staff can not return to the classroom until the areas passed testing. Affected areas include 8 classrooms:

- 1 preschool room
- 2 montessori rooms
- 5 year 3/4 rooms

The final testing results / report from ACT Property Group has not come in yet. The exact quantity of trace amounts is currently unknown.

## **4 Results**

#### 4.1 Observations

Poor lead containment practices were observed during air monitors setups in morning and air monitors pickup in the afternoon. Inadequate precautions before works commencing included furniture remaining in the work area not covered with plastic sheeting to prevent dust from settling on surfaces or entering fabrics (shown in Figure 5), as well as a lack of appropriate ground sheets in the interior and exterior work areas on the first day of works commencing (shown in Figure 5, Figure 6, and Figure 9 to Figure 13). The client was notified of this issue and drop sheets were used on following days, however ineffectual taping was evident throughout the course of works (shown in Figure 7 & Figure 8). As a result, debris consisting of flakes of paint were visually assessed beneath drop sheets to the interior carpet lining and to surrounding surfaces (as shown in Figure 7 – Figure 10). My apologies for the late email.

The results of the clearance swabs taken from one of the desk in Classroom Tracker location 014 in the Montesorri School is 0.2mg/m2 which is above the acceptance clearance level of 0.11.

Due to the low amount of lead dust remnants on the desk and the young children have only been in the classroom for 2 days, we determine that the potential health risk from exposure to lead dust particulate would be relatively low in this case, due to the level detected and the period of time that any one child would have been exposed.

It should be noted that there are other areas in the Montesorri school and Preschool that returned a higher results but the classrooms were not reoccupied and has since been environmental clean so there should not be any exposure risk concerns.

We have sent off the clearance swabs taken last night today and we should have the results tomorrow.
