

## Timeline for ACT public school 2019 enrolment

Applications can only be submitted via the ACT Education Directorate's website www.education.act.gov.au/enrolling

	Initial Enrolment Period

30 April 6:00am –	Applications are sent directly to the first school you listed on your application.
11 June 9:00am 2018	
	Applications received and considered
11 June – 1 July 2018	Applications received between 6:00am 30 April 2018 and 9:00am 11 June 2018 will be received and considered.
	ACT residents  All ACT children are guaranteed a place in an ACT Public School. K-12 students living within a priority enrolment area of a school are guaranteed a place at that school.
	While ACT resident families are still able to apply to enrol their child in a school that is outside their priority enrolment area, there is no guarantee of enrolment in that school. If the first school you listed on your application (outside your priority enrolment area) cannot offer enrolment, your application will be forwarded to the next school/s you listed. If none of the schools you listed can offer enrolment your application will be forwarded to your priority enrolment area (PEA) school <sup>1</sup> .  **NSW residents**
	Applications will be processed according to the <u>NSW Pathways arrangements</u> .
	Responses sent
2 July 2018	Applicants receive advice <sup>2</sup> from a school in response to their application.
	Accepting enrolment
2 July 2018 ongoing	Applicants arrange to visit schools to accept offers of enrolment as per advice from the school.
	Review and Appeals for Initial Enrolment Period
3 August 2018	Requests for review by school of declined enrolment close.
17 August 2018	Review decisions provided to applicants from school by this date.  Where a review is unsuccessful, parents may appeal the decision with the Directorate.
31 August 2018	Appeals against review decisions close.
21 September 2018	Appeal decisions provided to appellant by the Directorate.
	* Subsequent Enrolment Period  For applications submitted after 9:00am 11 June 2018
2 July 2018 ongoing	For applications submitted after 9:00am, 11 June 2018  Applications received after the Initial Enrolment Period will be considered as for the Initial
