





Thank you for your considered reply.

We appreciate the need for professional assessment and maintenance of the school environment, and fully support the decisions reached by Robson Environmental consultants and the ACT Health and Education Directorates. However, as per our last email, our main concern was with the timeframe in which these decisions were communicated to us and with the level of detail communicated. No correspondence received by Aeon Academy regarding the July building works contained specific times, dates, or locations in which work was to be carried out. This left our service without adequate information about a potential health hazard, despite Aeon Academy being the primary users of the site at that time. Although we are glad to hear that Robson Environmental consultants approved the school buildings for use, we would have been grateful to receive this assurance earlier.

Again, thank you for your offer of a meeting between Aeon Academy, YPS, and a representative from the Education Directorate, but we do not believe this to be necessary.

Thank you for your note regarding the communication from the school about the recent repair works undertaken during the school holidays.

Our school community were informed about the repair works on Monday 8 July, Wednesday 24 July and again on Friday 26 July. A further update was provided in the school newsletter on Thursday 1 August to advise that the remediation works will continue throughout Term 3.

In each of these communications, members of the school community were invited to contact me directly if they had a concern or wanted more information about the nature of the works being done. 10 families did contact me following the first email of Monday 8 July 2019 and I was able to answer their questions.

The Education Directorate is acting on the advice of specialist environmental consultants, Robson Environmental about this matter. On 4 July, representatives of the ACT Health Directorate and WorkSafe attended the site. Both are supportive of the remediation program which was undertaken during the holiday period. In addition, the Health Directorate is satisfied with Robson's assessment and the remediation measures being carried out. Robson has confirmed that Yarralumla Primary School has been – and remains – safe to occupy and operate as a school. This included the 'fairy garden' play space and preschool.

If you have further questions about the program of works at our school, I can arrange a meeting with yourselves and invite a representative from the Education Directorate to join us. Please let me know if you would like this to go ahead and your availability to meet.

I am writing regarding the repair work that was carried out during the recent school holiday period.

Aeon was not informed of the plans to remove asbestos and cover lead-based paint until the first day of our Vacation Program (July 8th). The notification we received was in the form of a letter to parents and carers (see below). The letter neither mentioned the buildings where the work

was to be conducted, nor the times and dates that it would occur (except that it would be sometime during the two weeks of our program).

We were disappointed by YPS's lack of communication at this time. Furthermore, we were concerned that works involving an airborne health hazard (asbestos) and possible additional risks associated with construction were carried out without informing or consulting with Aeon Academy.

We were not given the opportunity by YPS to discuss the health implications for our staff and the children attending our service.

We hope that communications will be clearer in future.
