#### **FLOREY OVAL**

#### Background

- The Education Directorate is refreshing a portion of the Florey dry land oval to maximise outdoor space for students at Florey Primary School.
- The Education Directorate is working closely with Transport Canberra and City Services (TCCS) on this project and feedback received through this engagement will help shape future plans for the oval.
- Community engagement commenced in July 2022 with the launch of a YourSay page which closed on Wednesday 7 September 2022.
- Community engagement activity was promoted through with Our Canberra, YourSay, school website and
  presentations to Belconnen Community Council (16 Aug2022) with two pop-up engagements held at the
  school and the local shopping centre in mid-August.
- We have already heard some great ideas from the school community in 2019 and again through this consultation process. A listening report is now being developed and consultation with the Ngunnawal community will occur for the portion of the oval being upgraded by the Education Directorate.

#### Summary of YourSay engagement – high level

- There were 58 individual submissions via the online survey with 65% of respondents saying that they currently use the oval mainly for walking, exercising animals and for personal exercise.
- Highest participation in the consultation were 30 to 39 years olds. While the majority said that they do not currently use the oval they have said they will do so once it is renewed.
- When asked why they wanted an oval refresh, the most common answers were for walking their dogs or for students to exercise on a safer surface, and for it to continue to be available to the public over weekends.
- When asked what elements would you like to see for the oval? The top 5 answers were:
  - Nature and imaginative play space.
  - Shaded areas

- Seating areas
- o Open irrigated greenspaces.
- o Trees.

### Identified risks

- Planning, design, construction and maintenance will be undertaken in partnership with Florey Primary School, local community, TCCS, Environment, Planning and Sustainable Development Directorate and other interested stakeholders.
- It continues to be important that we show the community that government is working together on this project.

### Next steps/actions

- Prepare Listening Report in consultation with TCCS for consideration by Minister and key stakeholders.
- Engage with Ngunnawal community on consultation feedback and seek input into designs.
- Connect the North Ainslie Primary School Principal and P&C as critical friends to Florey School, following their recent completion of their oval upgrade. (Sept 2022).
- Preliminary design concept plans (September/October 2022)
- Share through the ACT Government YourSay platform where the community will have a further opportunity to provide feedback (October/November 2022)
- Finalise design documentation (November/December 2022)
- Procurement, contractor engagement and equipment lead-in (January/April 2023)
- Florey Oval commence construction and completion (May/August 2023).

# REPORT ON WHAT WE HEARD

Canberrans were invited to have their say on the redevelopment of a portion of the Florey Dryland Oval from 27 July to 7 September 2022. The redevelopment will help create a natural outdoor space for students at Florey Primary School, who use this space every day, and the wider community for recreational use in the evenings and weekends.

Student ideas and input will also inform plans for this exciting new shared school and community space.

The redeveloped portion of the oval will become an educational and engaging space for students to access and enjoy every day as part of their learning.

Outside of school hours this public space will allow community to relax, exercise, meet, play, chat and connect.

The Education Directorate is working closely with Transport Canberra and City Services on this project and feedback received through this engagement will help shape future plans for the wider oval.

### THE CONVERSATION

### Student and school community engagement

In 2019 Florey Primary School students provided early ideas and sketches into what they would like to see the oval become.

During the engagement period the Florey Primary School Leadership Team and Parents and Citizens (P&C) were engaged to help shape and promote engagement opportunities through school newsletters, online, at meetings, and to gather student input.

Every class from the school had the opportunity to vote on the elements they wanted to see as part of the redevelopment. 782 student votes were received through this process.

#### Online survey

An online survey, via the YourSay website, was open during the consultation period for the community to provide feedback. A total of 58 surveys were completed. The community was also invited to provide feedback via email and Facebook.







#### Community pop-ups

Two pop-up sessions were held during the consultation period onsite at Florey Primary School, and at the local shops on 17 and 22 August 2022 to provide the community with an opportunity to ask questions.

The Education Directorate was also invited to present to the Belconnen Community Council via its online meeting on 16 August 2022. We spoke to over 50 people across these sessions.

# WHO WE ENGAGED

The consultation targeted students, families and staff from the Florey Primary School, Florey locals as well as residents from the broader Belconnen region.

We promoted the consultation via:

- a letterbox drop to 1200 homes in the suburb of Florey
- the Belconnen Our Canberra print newsletter and electronic newsletter
- ACT Government, Education Directorate and Florey Primary School social media accounts
- Education Directorate and Florey Primary School websites
- Florey Primary School newsletter and P&C meeting
- an email to key stakeholders including the Belconnen Community Council.

98.3% of survey respondents were from the Belconnen region. Residents with the majority of other responses from neighbouring suburbs were located centrally (1.72%).

# WHAT WE HEARD

### Key insights from the community

# What is important to the students at Florey Primary School

- 1. There is strong support from students to see bubblers (drinking fountains) included in the redevelopment (135 votes)
- 2. The next most supported elements were recreational, with students wanting to see a bike track built (86 votes), closely followed by goal posts (81 votes)
- 3. Picnic tables were equal third in students votes, alongside a nature and imaginative play space (73 votes each)
- 4. We also heard from students would like to see shaded areas incorporated in this space
- Access to the oval and safety is important to the school leadership, ensuring every student benefits from this refreshed space.

  Primary School students first, followed by community use in the evenings and weekends
- 2. The community sees this initial redevelopment as just the beginning for this project. Respondents said they would love to see the entire oval redeveloped over time
